The boundaries of judicial townships and voting precincts were changed to conform to the boundaries of supervisorial districts.

Mojave township & precinct extended to the north and western boundaries of the county.

Belleville township ran to the Colorado River, then to the intersection of the state line and the river, then to the N/E corner of the county, in Mesquite Valley, along the northern county line to 6 miles west of the San Bernardino Meridian, and finally south.

Bear Valley precinct ran to the Colorado River, too, Ivanpah precinct ran to the eastern boundary of the county, then east to the eastern Mojave Valley (Upper Bellville township).
